

## **“COLOR OF LAW COMPLAINT”**

***Lowndes County Judicial Circuit (Superior Court Judges, Chief Judge Harry Jay Altman II; Senior Judge Richard M. Cowart and Judge Richard Porter***

*Color of Law Violation – The FBI is the lead Federal Agency for Investigating Color of Law Violations, which include acts carried out by Government officials operating both within and beyond the limits of their lawful authority. Preventing abuse of this authority, however, is equally necessary to the health of our nation’s democracy. That’s why it’s a Federal Crime for anyone acting under “Color of Law” to willfully deprive or conspire to deprive a person of a right protected by the Constitution or the U.S. Law. Color of law simply means the person is using authority given to him or her by local, state, or federal government agency. (As stated by the FBI’s website)*

### **Color of Law Violations -**

**Title 18, U.S.C., Sec. 241 Conspiracy Against Rights** – It is unlawful for two or more persons to conspire to injure, oppress, threaten, or intimidate any person of any state, territory, or district in the free exercise or enjoyment of any right or privilege secured to him/her by the Constitution or laws of the United States, (or because of his/her having exercised the same).

**Title 18 U.S.C., Sec. 242 Deprivation of Rights Under Color of Law** – It is a crime for any person acting under color of law, statute, ordinance, regulation, or customs to willfully deprive or cause to be deprived from any person those rights, privileges, or immunities secured or protected by the Constitution and laws of the U.S.

**Title 18, U.S.C., Sec. 245 Federal Protective Activities** – (2) Prohibits willful injury, intimidation, or interference, or attempt to do so, by force or threats of force of any person because of race, color, religion, or national origin....

**Title 42, U.S.C., Sec. 14141 Pattern and Practice** – Civil Statute was a provision within the Crime Control Act of 1994 and makes it unlawful for any governmental authority, or agent thereof, or any person acting on behalf of a governmental authority, to engage in a pattern or practice of conduct by law enforcement officers or by officials or employees of any governmental agency with responsibility for the administration of juvenile justice or the incarceration of juveniles that deprives persons of rights, privileges, or immunities secured or protected by the Constitution or laws of the United States.

**Title 42, U.S.C., Sec. 1997** – The Department of Justice has the ability to initiate civil actions against mental hospitals, retardation facilities, jails, prisons, nursing homes, and juvenile detention facilities when there are allegations of systemic derivations of the constitutional rights of institutionalized persons.


**COMPLAINTS**

1. **“GEORGIA CODE OF JUDICIAL CONDUCT”  
PREAMBLE**

- (1) Our legal system is based on the principle that an independent, fair, and competent judiciary will interpret and apply the laws that govern us. The role of the judiciary is central to America concepts of justice and the rule of law. Intrinsic to all sections of this code are the precepts that judges, individually and collectively, must respect and honor the judicial office as a public trust and strive to enhance and maintain confidence in our legal system.
- (2) Every judge should strive to maintain the dignity appropriate to the judicial office. The judge is an arbiter of facts and law for resolutions of disputes and a highly visible symbol of Government under the rule of law. Judges should avoid both impropriety and the appearance of impropriety in their professional and personal lives. They should at all times exhibit behavior that ensures the greatest possible public confidence in their independence, impartiality, integrity, and competence. As a result, judges should be held to a higher standard, and should conduct themselves with dignity accorded their esteemed position.

We respectfully request that Judge **Richard Porter** Recuse himself from the Johnson’s case are be removed by the Chief Judge or the senior judge.


